I therefore request you to consider the avertments made in this affidavits and expedite the process of Affiliation.

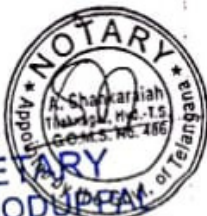


